**What Is The Scheme :**

Congratulations to all your family members on the birth anniversary of Lord Vishwakarma. On this occasion, we sincerely congratulate you. Prime Minister Narendra Modi announced the 'Vishwakarma Yojana' from the Red Fort. The Prime Minister of India, Shri Narendra Modi and the Ministry of Micro, Small and Medium Industries have launched the Pradhan Mantri Vishwakarma Shram Samman Yojana 2023.

PM Vishwakarma Scheme is classified as a Central Sector Scheme. Under which all artisans will get a low interest loan of Rs 3 lakh from the government which they can use to expand their shop or business. Prime Minister Narendra Modi said the project will be launched in September 2023 on the occasion of Vishwakarma Puja. Pradhan Mantri Vishwakarma Kaushal Samman Yojana which was announced to be launched by Finance Minister Nirmala Sitharaman in the Budget 2023-24. Backed by a significant financial commitment. Its implementation is set for a broad five-year period spanning from 2023-24 to 2027-28.

It aims to provide benefits to a large number of people belonging to the Vishwakarma community. The project is named after Lord Vishwakarma and aims to provide skill development and technical training opportunities to persons of the Vishwakarma community. Pradhan Mantri Vishwa Karma Yojana will become a means of nation building and empowerment of crores of artisans of the country. Kudos to all these artisans and manufacturers who are driving innovation in society with their dedication, talent and hard work. An economic support package for traditional crafts and artisans under this initiative has also been announced in the Union Budget.

Moreover under the Pradhan Mantri Vishwakarma Yojana, those who apply online will be given an identity card under the scheme. PM Vishwakarma certificate and ID card will be given to artisans covered under PM Vishwakarma scheme. For this registration free training will be given not only to the persons registered under this scheme. They can also take loans at low interest rates. 15,000 will be given for purchase of equipment after completion of training. Apart from this, first Rs. 1 lakh at 5 percent interest. Then, if necessary, a loan of 2 lakh rupees will be given in the second installment.

13 to 15 thousand crore rupees will be allocated in this scheme on which no interest will be charged. The Prime Minister said that the government will help people with traditional skills through this scheme. Through this project these communities will get an opportunity to improve their skills and get access to technical education and financial assistance. About 140 different castes are part of the Vishwakarma community, living in different regions of India. It will include and assist people with traditional skills like blacksmiths, barbers, goldsmiths and labourers, masons. The amount paid to the workers under the Pradhan Mantri Vishwakarma Yojana 2023, Shram Samman Yojana will be directly transferred to the bank accounts of the beneficiaries.

For this it is mandatory for the applicant to have a passbook account. Government's efforts to provide support for autonomy and development through this program. Crores of traditional artistes of the country will benefit from Vishwakarma Kaushal Samman Yojana. Those who work with their hands and tools.

We will share with you complete information about PM Vishwakarma Yojana 2023 online registration, required documents, eligibility etc. through this article.

Finance Minister Nirmala Sitharaman announced the launch of Pradhan Mantri Vishwakarma Kaushal Samman Yojana i.e. Pradhan Mantri Vishwakarma Kaushal Samman Yojana during the Budget 2023-24. This scheme is going to benefit such a large population comprising the Vishwakarma community. Under this scheme, loan assistance of up to Rs.1 lakh and Rs.2 lakh will be provided to artisans and traditional artisans in 2 installments at 5 percent interest rate.

The project is named after Lord Vishwakarma. According to the available information, about 140 castes come under Vishwakarma community, living in different regions of India. Under this scheme, people of this community will be given opportunities to enhance their skills. They will be helped to learn technology and the government will also give them financial support. Under this scheme, a financial assistance package has been announced in the Union Budget for traditional artisans and craft artisans.

The Pradhan Mantri Vishwakarma Yojana will strengthen the family-based tradition of traditional skills of artisans and craftsmen. Under this scheme, loans up to Rs 1 lakh (first installment) and Rs 2 lakh (second installment) will be provided to artisans and craftsmen at an interest rate of 5 percent. Along with this, 'PM Vishwakarma Certificate' and an ID card will also be issued. According to an official statement, there will be two types of skill programs under the scheme – basic and advanced.

During skill training, beneficiaries will be given stipend of Rs.500/- per day and beneficiaries will get assistance up to Rs.15000/- for purchase of modern equipment. The 'Pradhan Mantri Vishwakarma Scheme' was approved in the Union Cabinet meeting held on 16 August 2023 and will be launched on the occasion of Vishwakarma Jayanti on 17 September 2023. 13,000 crore in the scheme over a 5-year period (FY 2024 to FY 2028) to support around 30 lakh families of traditional artisans and craftsmen including weavers, goldsmiths, blacksmiths, laundry workers and barbers.

## **Purpose**

Vishwakarma Scheme seeks to improve the quality and availability of goods and services produced by these skilled artisans. It seeks to provide a platform to these artisans to showcase their talent and creations. Not only locally but also on the global stage. The objective of this scheme is to provide financial assistance to artisans. The scheme will help promote and strengthen the practice of artisans' traditional skills. It also promotes the digital empowerment of Vishwakarma. Through this they can enhance their skills and promote their services in the market. Under this scheme, the artisans will get an opportunity to be encouraged. It will also help in proper delivery of goods and services to the artisans. Beneficiaries of this scheme will get a toolkit worth Rs 15,000. Besides, the beneficiary will also get a stipend of Rs.500 per day along with skill training. The main objective of this project is to develop artisans and make them self-reliant. They will be able to improve their business with the loan provided at 5% interest rate. As a result of which their financial status will improve. Under this project, the artisans will get an opportunity to be encouraged. This scheme helps artisans to get employment opportunities and will help improve their economic status. Under this scheme, on the one hand, the beneficiaries will get advanced training, on the other hand, the focus will be on the economic development and economic support of the beneficiaries. Government has more motive behind launching this project. Which we have pointed out below for your understanding –

1. The project also aims to enable identification of artisans and craftsmen.
2. Upgrading skills to improve and build skills of craftsmen and artisans.

8. The scheme also aims to provide incentives for digital transactions.
9. Providing a platform to promote and market the brand. and helping them access new growth opportunities.
10. Pradhan Mantri Vishwakarma Kaushal Samman Yojana This scheme is specially launched for Scheduled Castes, Tribes, OBC women and socially backward people.

The scheme aims to improve the quality, scale and reach of products and services to artisans and craftsmen. Also this Vishwakarma empowers the practitioners. Preserving the essence of traditional crafts enables them to thrive in the contemporary world. By doing so it ensures preservation of our heritage while increasing economic growth and opportunities for these artisans.

## Main Points

- Minimum 18 years of age and one member per household is eligible. Government servants or their relatives are not eligible.
- Various traditional and skilled artisans and craftsmen will be empowered through Pradhan Mantri Vishwakarma Kaushal Bikash Yojana.
- The government has started this program for traditional artists and artisans.
- (PM VIKAS) PM has announced a financial support package for traditional artisans and craftsmen in the Union Budget through Vishwakarma Kaushal Samman Yojana (Pradhan Mantri Vishwakarma Yojana).
- Vishwakarma Kaushal Samman Yojana (PM VIKAS) will help these artisans to improve the quality of their products and help them in marketing and distribution.
- About 140 castes (blacksmiths, potters, craftsmen, artisans, goldsmiths, masons etc.) will get direct benefits under Vishwakarma Kaushal Samman Yojana.

- The project includes 18 traditional businesses in both rural and urban areas. These include carpentry, boat building, blacksmithing, pottery, sculpture, cobbler, sewing and more.
- Applicants will receive a PM Vishwakarma certificate and identity card.
- With a budget of Rs 13,000 to 15,000 crore over five years (2023-2028), the scheme provides a stipend of Rs 500 for skill training and Rs 1,500 for purchase of modern equipment.

- The main objective of this project is to seamlessly integrate artisans indoors and outdoors. and increasing their market access and growth opportunities.
- Artisans can register at Village Common Service Centers funded by Central Government and State Government assistance.
- Under this scheme the artisans will be trained for their work and the government will also provide financial support to those who want to start their own employment.
- Under Vishwakarma Skill Development Scheme, not only money but also new technology will be made available to handicraftsmen.
- The scheme also plans to link artisans with national and international banks for bank promotion
- Applicants of this scheme are eligible for collateral-free credit assistance. 1 lakh in the first phase and up to 2 lakh in the second phase. Both will earn 5% interest.

## **Benefit**

- The government will provide loans up to Rs 1 lakh in the first phase and up to Rs 2 lakh in the second phase to those who have joined the Pradhan Mantri Vishwakarma Yojana.
- The benefits of PM Vishwakarma Yojana 2023 will be provided to traditional artisans and craftsmen associated with our 18 businesses in the country to ensure their continuous development.

- Through this scheme you will be given a loan of Rs 3 lakh for 4 years.
- You have to pay 5% interest on a loan of Rs 3 lakh.
- About 30 lakh families of traditional artisans and craftsmen will benefit.
- Also, the ministry in which you are competent will train you.

- You will also be given a certificate recognized by the government.
- During the training you will get a toolkit worth 15000 rupees. Which will help you more.
- and will help reduce the unemployment rate.
- These loans will also be given to artisans at low interest rates.
- Government will provide free training under this scheme.
- Upon completion of the training, a certificate will be awarded.
- Through which he can work according to his training.

## Beneficiaries

The PM Vishwakarma Yojana is designed to benefit artisans specializing in 18 traditional trades. It will provide support to artisans and craftsmen in rural and urban India. Individuals in any of these 18 types of jobs can avail this scheme. The entire cost of all types of training provided under this scheme will be borne by the State Government. These businesses encompass a variety of professions. Which includes –

This comprehensive coverage ensures that the artisans of various traditional branches can avail the benefits of this scheme to improve their livelihood. Initial free training will be provided for 6 days. And financial

assistance ranging from 10 thousand to 10 lakh rupees will also be provided. 15 thousand people will be employed every year under this project. The entire cost of all types of training provided under this scheme will be borne by the State Government.

## **Budget**

Prime Minister Narendra Modi announced the Vishwa Karma Yojana on the occasion of Independence Day this year. The scheme was launched on 17th September 2023. This scheme was announced in the Union Budget 2023-24. Prime Minister Modi also announced the scheme on Independence Day this year. The government will spend Rs 13,000 crore on this project. Beneficiaries of this scheme are also given advanced training. This expenditure has been put on hold till the fiscal year 2027-28.

In a second important decision, the Cabinet Committee on Economic Affairs chaired by Prime Minister Narendra Modi approved the expansion of the already ongoing Digital India scheme. Under which 6.25 lakh IT professionals will be up-skilled at a cost of Rs 14,903 crore. Also 2.65 lakh people will be trained in IT.

- **Pradhan Mantri Vishwakarma Yojana Interest Rate (2023) –**

Under this scheme people will be given loan at interest rate. The interest rate for this has been fixed at 5 percent. In the first phase, people will be given a loan of 1 lakh rupees, in the second phase, a loan of up to 2 lakh rupees can be taken.

- **How much loan will be available under this scheme and what will be the interest rate?**

A loan of up to Rs 3 lakh in two installments at a concessional interest rate of 5 per cent per annum will be given to all the artisans and craftsmen eligible for Vishwakarma Yojana.

- **Pradhan Mantri Vishwakarma Yojana Loan Amount and Repayment Period –**

People coming under this scheme can take loan upto Rs 3 lakh in total. Initial Enterprise Development Loan upto Rs.1 Lakh. The duration of which is 18 months. No prepayment fee will be charged from those artisans and craftsmen who want to make any prepayment after 6 months of loan disbursement.

- **Details of Pradhan Mantri Vishwakarma Yojana Benefits for Small Businesses, Implementation Timeline and Fund Allocation –**

1. The implementation timeframe spans around Rs 13,000 to 15,000 crore.
  2. Significant government commitments have been made to advance this project.
- **You will get Rs 500 per day –**

The Vishwakarma scheme will have two types of skill development programs of which the first will be 'Basic' and the second will be 'Advanced'. Those doing this course will also get sammani (stipend). Beneficiaries who receive skill training will be given an honorarium of Rs.500 per day. Under the scheme, the first phase will provide a loan of up to Rs 100,000 on which interest will be payable at a maximum rate of 5 per cent. 2 lakh discount will be given in the second phase after organizing the business.

- **Repayment Period (in Months) –**

1. 1st phase loan amount can be Rs.1,00,000 to be repaid in 18 months.
2. 2nd phase loan amount can be Rs.2,00,000 to be repaid in 30 months.

- **Additional assistance of Rs.15000 –**

Artisans and artisans under PM Vishwakarma scheme will be recognized by Prime Minister Vishwakarma certificate and also given Vishwakarma ID card. Under this scheme, the artisans will be provided incentives and market support in digital transactions. Thus, artisans and craftsmen will be given an additional assistance of Rs 15,000 for purchase of modern equipment to improve, speed up and improve quality of their work.

- **Amount received under Pradhan Mantri Vishwakarma Yojana**

A person who is undergoing training under Pradhan Mantri Vishwakarma Yojana Pradhan Mantri Vishwakarma Yojana 2023 is given Rs 500 as grant and in addition Rs 15000 assistance to purchase a tool kit. A loan is also given under this scheme. If you take a loan up to Rs 1 lakh, you will not be charged interest. If you borrow more than this, you are given a discount of 5% interest rate.

- **3 lakhs loan available at 5% interest –**

Under the Pradhan Mantri Vishwakarma Kaushal Samman Yojana (Pradhan Mantri Vishwakarma Yojana), the government will provide loans of up to Rs.3 lakh. The benefits of which are to make artisans and craftsmen self-reliant. This loan will be given in two installments. 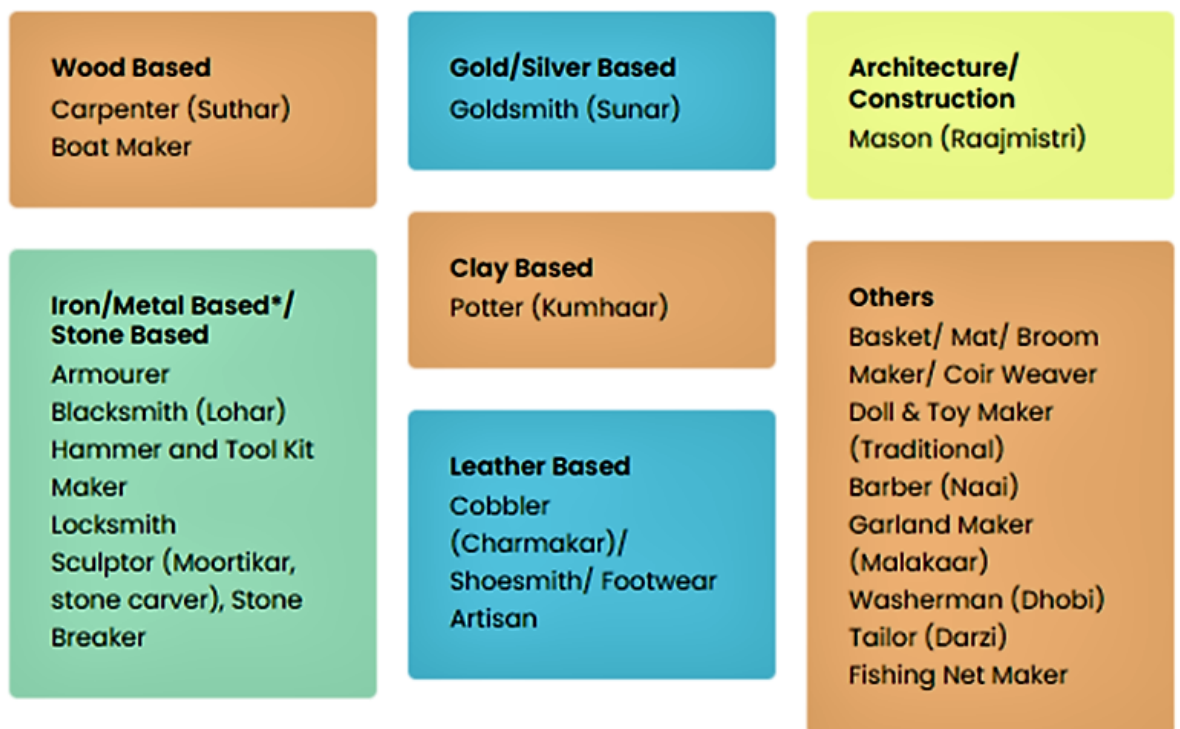
Pradhan Mantri Vishwakarma Kaushal Samman Yojana (Pradhanmantri Vishwakarma Kaushal Samman Yojana) was announced by India's Finance Minister Nirmala Sitharaman in the Union Budget 2023-24. It can be initiated on September 17 Vishwakarma Jayanti.

### **Eligibility Criteria**

- All applicants must be native citizens of India.
- Applicant age should be more than 18 years and less than 50 years.

- Applicant must be a small worker/worker.
- Applicant's annual income should be less than 2 lakh 40 thousand rupees.
- In this scheme, 140 castes under Vishwakarma Community will be eligible to apply.
- People should have important documents to apply for the scheme.
- Only one member of a family can apply under this scheme.
- All artisans will be eligible to register under Pradhan Mantri Vishwakarma Yojana.
- Applicant's bank account should be linked with Aadhaar card.
- An artisan engaged in one of the 18 family-based traditional occupations mentioned in the scheme will be eligible for registration under PM Vishwakarma.
- Finally other qualifications have to be fulfilled to get release under this scheme etc.
- Farmers have to meet all standards set by the government.

## Eligible Trades



### Not Eligibility Criteria

- If you are availing credit based scheme of any other state government or central government then you will not be eligible for this scheme.
- Persons working in government service and their family members will not be eligible under this scheme.
- Other family members have not applied for it under this scheme.

### **Literacy Program under Pradhan Mantri Vishwakarma Yojana –**

Under this literacy programme, the state government provides assistance to migrant workers and traditional workers. Eg – 18 different types of jobs will be trained. The state government provides stipend to the workers for the training period and for purchasing their equipment. The amount of assistance will also be provided.
